- Trevyn wanted clarification on the decision that was made at the last City Council meeting regarding the potential for Water Meters to serve the (4) tracts located near Well #10.
- Council voted on 7/26//23 and the motion read as follows: *"MOTION: Chupp moves Machen seconds to service city water to all four tracts of land surrounding Well #10, to include a meter installation fee of \$5,000 per meter to each tract, and to prohibit the drilling of any water wells on any part of these four tracts now, and forevermore. This motion is void shall any of the landowners and/or purchasers of said tracts of land refuse any of these terms. Motion carries 3-1."*
- The terms were not met so therefore, there will be no city water provided to any of these tracts.
